



GENERAL TERMS OF REGISTRATION

The registration fee for the PK/PD Expert Meeting is charged per person and is exempt from VAT in accordance with Section 4 No. 22(a) of the German VAT Act (UStG). Fees are charged and collected on behalf of AGAH e. V., Goernestraße 30, 20249 Hamburg, Germany (VAT ID No. DE25876120).

The participant will receive a written registration confirmation and invoice containing the applicable payment details and payment deadline. CSi Hamburg GmbH handles registration and payment administration on behalf of AGAH e. V.

CANCELLATION

In the event of cancellation:

- up to 50 days before the start of the event (23 February 2027) → full refund (less 15.00 € plus VAT, if applicable, handling fee)
- from 49 to 29 days before (24 February – 16 March 2027) → 40 % of the participation fee will be charged (plus 15.00 € plus VAT, if applicable, handling fee)
- from 28 days before (17 March 2027) → no refund possible

All refunds will be processed after the event. A registered participant may nominate a substitute participant at any time before the event. Each substitution or subsequent change of participant details is subject to a handling fee of 15.00 € plus VAT, if applicable. This fee will be charged only once per change. All cancellations or changes must be submitted in writing to CSi Hamburg GmbH.

INVOICE AMENDMENTS

Subsequent invoice amendments requested by the participant will be subject to a handling fee of 15.00 € plus VAT, if applicable. No fee will be charged where the amendment is required due to an error attributable to AGAH e. V. or CSi Hamburg GmbH.

PAYMENT TERMS AND LATE PAYMENT

Registration fees are due within four weeks of the invoice date, unless a different payment deadline is stated on the invoice. If payment has not been received by the due date, a payment reminder may be issued. A reminder fee of 10.00 € plus VAT, if applicable, may be charged where legally permissible. If payment is not received within two weeks after the reminder, AGAH e. V. reserves the right to cancel the registration and reassign the place. Any cancellation or reminder fees already incurred remain payable.

LIABILITY

AGAH e. V. is the scientific and legal organizer of the event. CSi Hamburg GmbH has been commissioned to provide participant and registration management services on behalf of AGAH e. V.

AGAH e. V. and CSi Hamburg GmbH shall be liable without limitation for damage caused intentionally or through gross negligence and for damage resulting from injury to life, body or health.

In cases of slight negligence, liability shall be limited to breaches of material contractual obligations and to foreseeable damage typical of the contract. Material contractual obligations are obligations whose fulfilment is essential for the proper performance of the contract and on whose fulfilment the participant may regularly rely. Any mandatory statutory liability remains unaffected.
