REGISTRATION

The Fees for the AGAH Applied Course is per person, according to §4, para. 22, German Turnover-Tax Law exempt from VAT and charged and collected on behalf of AGAH e. V., Goernestraße 30, 20249 Hamburg/Germany (taxpayer ID number: DE25876120).

The participant will receive a written confirmation/invoice with paying details first and have to pay the registration fee within the payment period. If payment is not made within the deadline, the registration will be cancelled.

CANCELLATION

Cancellations made up to 10 weeks (70 German working days) before the start of the event (April 1, 2023) will be charged 25 % of the registration fee; up to 06 weeks (42 German working days) before the start of the event (April 29, 2023) 50 % will be charged; up to 04 weeks (28 German working days) before the start of the event (May 13, 2023), 80 % of the fee, each plus € 15.00 incl. VAT processing fee, will be charged. A cancellation received after May 13, 2023 is not refundable. All refunds will be settled after the event. Substitutes will be accepted at any time and will be charged with 15.00 € incl. VAT processing fee. Name changes received 2 weeks or less before the start of the course will be charged with 25.00 € incl. VAT. All changes or cancellations must be submitted to CSi Hamburg GmbH in writing.

INVOICE ADJUSTMENT OR CHANGE

Each invoice adjustment or change will be charged with 15.00 EUR incl. VAT.

LIABILITY
