#### **REGISTRATION**

#### **CANCELLATION**

Cancellations made up to 10 weeks (60 German working days) before the start of the event (July 27, 2023) will be charged 25 % of the registration fee; up to 6 weeks (46 German working days) before the start of the event (August 24, 2023) 50 % will be charged; up to 4 weeks (24 German working days) before the start of the event (September 7, 2023), 80 % of the fee, each plus € 15.00 incl. VAT processing fee, will be charged. A cancellation received after September 7, 2023 is not refundable. All refunds will be settled after the event. Substitutes will be accepted at any time and will be charged with 15.00 € incl. VAT processing fee. Name changes received 2 weeks or less before the start of the course will be charged with 25.00 € incl. VAT. All changes or cancellations must be submitted to CSi Hamburg GmbH in writing.
