

GENERAL TERMS OF REGISTRATION

REGISTRATION

The Fees for the PK/PD Expert Meeting is per person, according to §4, para. 22, German Turnover-Tax Law exempt from VAT and charged and collected on behalf of AGAH e. V., Goernestraße 30, 20249 Hamburg/Germany (taxpayer ID number: DE25876120). The participant will receive a written confirmation/invoice with paying details first and must pay the registration fee within the payment period. If payment is not made within the deadline, a reminder fee of 10.00 EUR incl. VAT will be charged. CSi Hamburg GmbH act with mandate and on behalf of the AGAH e. V.

CANCELLATION

In the event of cancellation up to 50 days before the start of the event (24 January 2024), the fee will be refunded; in the event of cancellation from 49 days before the start of the event (25 January 2024), 40 % of the participation fee will be charged; in each case plus 15.00 EUR incl. VAT. handling fee. In case of cancellation 28 days or more before the start of the event (15 February 2024), no refund can be made. All refunds will be settled after the event. Substitutions will be accepted at any time and will be charged at 15.00 EUR incl. VAT handling fee. Name changes received 2 weeks or less prior to the start of the course will be charged 15.00 EUR incl. VAT. All changes or cancellations must be submitted in writing to CSi Hamburg GmbH.

INVOICE ADJUSTMENT OR CHANGE

Each invoice adjustment or change will be charged with 15.00 EUR incl. VAT.

PAYMENT TARGET / PAYMENT DELAY

Registrations without payment within 4 weeks after invoicing (the date of issue counts) will incur a reminder fee 10.00 EUR, which must be paid in any case. Registrations, further 2 weeks without payment after receipt of the reminder fee, are considered cancelled and the place will be given to colleagues on the waiting list. The reminder fee must be paid in any case. These fees are independent of the regular cancellation fees.

LIABILITY

CSi Hamburg GmbH shall be liable in the framework of a duty of care as a respectable businessman according to statutory provisions. Liability of CSi Hamburg GmbH – for whatever legal reasons – is limited to intent and gross negligence. The liability of commissioned service providers shall remain unaffected by this.
